The Company had appointed National Securities Depository Limited (NSDL) as the service provider for extending the facility for the Remote E-voting to the Shareholders of the Company from Friday, 8th November 2024 at 09:00 A.M. The Company completed the dispatch of the Notice of the meeting by electronic mode to those equity shareholders whose email IDs are registered with the Company by 9th October, 2024 and has also published an advertisement in this regard, in English language in "Business Standard" (Kerala Edition) on Thursday, 10th October, 2024and translation thereof in Malayalam language in "Kerala Kaumady" (All Editions in Kerala), on Thursday, 10th October, 2024 respectively.
- 3. The Cut-off date was fixed at Monday, 4th November, 2024 for the purpose of deciding the equity shareholders entitled to vote through remote e-voting and votes through E-voting System provided by NSDL at the venue of the meeting on the resolution seeking their approval.
